Adoption Application

Terms and Conditions

- I, the Adopter, understand that Wild Horse Rescue Inc. cannot guarantee that the specific horse I am wanting will be available at the time that I am available to pick up the horse. However, Wild Horse Rescue Inc. will notify me as soon as the horse is available.
- I, the Adopter, agree to maintain a proper nutrition program for the horse including quality forage, proper feed & supplements, and access to fresh water at all times.
- I, the Adopter, also agree to provide satisfactory care of the horse including, but not limited to, routine licensed veterinary care, routine worming & check-ups, farrier care, proper fencing & shelter, an environment that is clean, and daily turn out space in order to maintain the health of the horse.
- Wild Horse Rescue Inc. retains ownership of the adopted horse for a period of 1 (one) year, from date of adoption, insofar as it pertains to defining proper care and treatment of the adopted horse. Wild Horse Rescue Inc. or a Wild Horse Rescue Inc. Representative reserves the right to remove any horse adopted from Wild Horse Rescue Inc., in Adopters care, if it is found that the horse is not being properly cared for as previously described. No adoption fee(s) or monies of any kind will be refunded to the Adopter.
- Wild Horse Rescue Inc. reserves the right to random visitation to insure the adopted horse is being properly cared for during the 1 (one) year period as previously stated. Wild Horse Rescue Inc. must provide a minimum of twenty-four (24) hours advanced notice of their intent to perform such a visitation.
- I, the Adopter, also agree to provide Wild Horse Rescue Inc. during the one (1) year from the date of adoption, with updated location information should the horse be moved to a location other than specified in the initial Adoption Application Form.
- During the 1 (one) year period, the adopter cannot sell or transfer ownership of the horse. All papers that were given to the Adopter will also be returned to Wild Horse Rescue Inc. along with the horse if the Adopter can no longer keep the horse.
- Wild Horse Rescue Inc. or one of its Representatives has 14 days from the time of notification, to finalize transfer and pick up horse should the adoption be cancelled.
- If a deposit is given to Wild Horse Rescue Inc. and I change my mind about adopting a horse, I will receive a refund, minus 20%.

- If I do not pick up the horse when agreed, a feed and board charge will be added to the cost of the horse.
- I understand that within a period of 1 week, if I am not happy with the horse, I can return said horse to Wild Horse Rescue Inc., provided it is in as healthy a condition as when I adopted it and I will receive back the entire adoption fee that was paid, minus 20%.
- I agree that if not returned to Wild Horse Rescue Inc., I will keep the horse for a period of no longer than one year and if I, after that time, decide to sell the horse that I will not sell it to any person, organization, company, or entity where it is known, suspected, or rumored that the horse will be in danger of going to slaughter.
- I further agree that Wild Horse Rescue Inc. cannot be held responsible for any unforeseen health problems occurring with the horse and fully understand that even "Blue Blooded" or "Select" horses sometimes have or develop various health problems.
- By filling out and indicating my approval on this Adoption Application Form, I have every intention of adopting the named horse from Wild Horse Rescue Inc. and that should my circumstances change I will notify Wild Horse Rescue Inc. as soon as possible.
- Wild Horse Rescue Inc. will hold all information received in the Adoption Application Form in strict confidence and will not share any information contained in the Adoption Application Form with any "Third Party".
- By indicating my approval on this Adoption Application Form, I declare that all of the information that I have provided is true to the best of my knowledge and if found to be false or fraudulent I will be denied approval for adoption.
- I have read and fully understand the contents of the above Adoption Terms and Conditions and further understand that they are non-negotiable and will be incorporated into the final Adoption Contract.
