## Foster Care Agreement

Wild Horse Rescue Inc. desires the Caregiver to hold said horse for Wild Horse Rescue Inc. in the absence of Wild Horse Rescue Inc. and its Representatives until \_\_\_\_\_. At which time, caregiver has the option to purchase above named horses for \$ \_\_\_\_\_. Should the Caregiver not exercise his option to purchase said horse, **Wild Horse Rescue Inc. will reclaim the horse and remove it from the caregivers Premises within 5 days.** Wild Horse Rescue Inc. and Caregiver recognizes that the Caregiver cannot hold said horse for Wild Horse Rescue Inc. for an indefinite period of time. In consideration of the premises and the covenants herein contained, it is agreed between the Caregiver and Wild Horse Rescue Inc. as follows:

1. Wild Horse Rescue Inc. hereby delivers to and deposits with the Caregiver said horse.
2. Upon Wild Horse Rescue Inc.'s return to the Caregivers property where horse will be kept, the Caregiver will return the horse to Wild Horse Rescue Inc, which will be accomplished as soon as is practical or the horse has been successfully adopted.
3. Due to the unknown duration of care, and the need of the Caregiver to know when the foster arrangement will be concluded, Wild Horse Rescue Inc. agrees that the Caregiver will not be responsible for keeping the horse from the date listed above on this Agreement; further if Wild Horse Rescue Inc does not return to the Caregiver's Property and accept return of the horse within said twelve (5) day period or if Wild Horse Rescue Inc. states in writing to the Caregiver that the organization no longer desires return of said horse, then Wild Horse Rescue Inc. relinquishes any claim, right, title, or interest in said horse; and the said horse becomes the property of the Caregiver and the Caregiver may exercise complete discretion as to what to do with the horse.
4. Caregiver agrees to provide adequate food, water, shelter, and humane treatment for said horse at all times. In addition, Caregiver agrees to adhere to all state and local animal laws. Foster Caregiver agrees to follow all oral and/or written additional instructions from Wild Horse Rescue.
5. If said horse dies or becomes accidentally injured, ill, or lost, Wild Horse Rescue Inc. does not hold the caregiver responsible and releases the Caregiver from any claim arising from said injury. In addition, if said horse bites or injures any human or other animal, Wild Horse Rescue Inc is not liable and will hold harmless and indemnify, and protect the Caregiver, from any claim or suit filed by anyone as a result of such an incident.
6. In the event a Medical Emergency occurs with the horse, The Caregiver must make every attempt to contact Wild Horse Rescue Inc. The Caregiver reserves the right to seek Emergency veterinary care at the expense of caregiver. If the Medical attention needed is not an Emergency, the Caregiver must contact Wild Horse Rescue Inc, to make further arrangements for said care. If the medical attention needed was deemed to be not an emergency by the Veterinarian and Wild Horse Rescue Inc. did not previously authorize the Veterinary visit, the Caregiver is liable and responsible for payment of all charges incurred for treatment of said horse. In addition, the Caregiver reserves the right to euthanize the horse should a veterinarian deem the horse's health to be so impaired that to sustain the horse would be inhumane.
